All that tract of land located in Grove Township, State and County aforesaid, containing thirty two acres bounded by lands of Dayton Clark and P. F. Cox on Log Shoal Road and by H. F. Riddle, Fred Cox and others, being a part of the land conveyed by J. E. Ashmore to Bessie S. Ashmore, bearing date Feb. 19, 1916, being part of the land conveyed to S. J. Cox by Bessie S. Ashmore bearing date of Jan. 6, 1917 in book G page (37) and more particularly described as follows, beginning at a stone corner of the south edge of Log Shoal Road corner of land of Dayton Clark and Fred Cox, thence S. 57° 34' W. 18.65 to corner in Log Shoal Road, thence with Log Shoal Road S. 54° 34' E. 84 ft. to iron pin corner of lands of P.
