KNOW ALL MEN BY THESE PRESENTS, That I Hattie B. Stearns, of the City and County of Greenville and

in the State aforesaid, in consideration of the sum of Three thousand and no/100 (3000.00) DOLLARS, to me in hand paid at and before the sealing of these presents by Ed. C. Cudde and Robert Wilson

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Ed. C. Cudde and Robert Wilson, their heirs and assigns

Three, one-half interest in and to; all those certain pieces, parcels and lots situated lying and being in the County and State aforesaid, in Chick Sherlings Township, about five miles East of Greenville City and being known and designated as lot No. 47, 48 plat of Wharton property, recorded in R.M.C. Office for said County in plat book "E" at page 50 and being vis. the lots conveyed to me by E.M. Wharton by deed dated Sept. 10th 1917, and recorded in R.M.C. office for said County in Deed Book Vol. 52 at page 52.

Also all that other certain piece, parcel and lot of land situated, lying and being adjoining the above described and being known and designated as lot #50, having the following metes and bounds, to-wit: Beginning at a stake in the corner of lots Nos. 47 and 48, eighty feet from the National Highway and running thence N. 29.44 W. Sixty feet to a stake in lands of said E.M. Wharton; S. 60.16 E. Twenty eight feet to a stake in lands of said E.M. Wharton; S. 29.44 E. Fifty feet to a stake in line of lot #46 three feet from the stake corner of lots Nos. 46 + 47; thence N. 60.16 E. Twenty eight feet in line of lots Nos. 46 + 47 to the beginning corner.
