

Whereas, since Janie Cothran, Anna Louise Rhodes, Emma Gossett, Anna Coker and Georgia Ann Davenport, own a tract of land in common, each one undivided one fifth part:

KNOW ALL MEN BY THESE PRESENTS, That We, Anna Louise Rhodes, Emma Gossett, Anna Coker and Georgia Ann Davenport

in the State aforesaid, in consideration of the sum of One hundred dollars and other considerations hereafter mentioned to us in hand paid at and before the sealing of these presents by Janie Cothran

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Janie Cothran, and her heirs and assigns forever, All our interest, which is

one undivided one-fifth part each, in a certain tract of land containing 38-2/3 acres, be the same more or less, it being tract No. 3 in a division of the tract of land formerly owned by L.M. Chapman, sometimes known as the Cason Place, described as follows: Beginning in center of public road with Anna Coker on W.H. Smiths line; thence N. 55 E. 13.12 chains to a stake 3X; thence N. 71-1/2 E. 16.04 chains to a stake 3X; thence N. 6-1/2 E. 29. chains to a stake 3X; thence S. 72 W. 5.76 chains to a stake 3X; thence S. 8 E. 4.61 chains to a stake 3X; thence S. 4 E. 14.71 chains to a stake 3X; thence S. 56 W. 25.19 chains to a stake 3X in public road; thence S. 23-1/2 E. 7.50 chains to the beginning 3X. The road being the line from the last stake to the beginning.

Bounded by lands of W.H. Smith, T.O. Cooley, Wade Albertson, Emma Gossett and Anna Coker. Now this land is a part of the tract of land deeded to Georgia Ann Davenport by D.P. Verner, Master for Greenville County in a deed recorded in the Registers office for Greenville County in Vol. KKK, page 22.

In a deed recorded in Vol. LLL, page 166, in the Registers office for Greenville County, Georgia Ann Davenport deeded to Janie Cothran Anna Louise Rhodes, Emma Gossett and Anna Coker to each, one undivided one-fifth part of said land reserving to herself one undivided one-fifth part.

Now these parties owning this land have had it surveyed, find said tract to contain 172 acres, have had it divided into 5 tracts, which they consider equal in value, and have set them off as follows, Tract No. 1-27 acres to Anna Coker, tract No. 2-29 acres to Georgia Ann-Davenport, tract No. 3-38-2/3 acres to Janie Cothran, tract No. 4-38-2/3 acres to Emma Gossett and tract No. 5- 38-2/3 acres to Anna Louise Rhodes, each wishing to own their tracts individually, have mutually agreed to sign deeds interchangeably one to the other. For a further description of this land would refer to a plat made by J.M. Cox, Surveyor Feb. 1918. Said land is situated in Dunklin Township, Greenville County, So. Carolina.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said Janie Cothran, & her heirs and assigns, forever.

AND We do hereby bind ourselves, our heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Janie Cothran & her

heirs and assigns, against us and our heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
