at and before the sealing of these presents by F.A. Lawton

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release
unto the said F.A. Lawton, All that certain lot of land situate in the County of Greenville,

State of South Carolina, known and designated as lot No. 8 of the subdivision of lands of
P.D. Cureton, deceased, as shown on plat recorded in the R.M.C. Office for Greenville County,
Plat Book E., page 33, and more particularly described as follows:
Beginning at a stake on a 20 foot road leading from Augusta Road in a northeasterly direction
at corner of lot No. 9 (now the property of F.A. Lawton), and running thence with the line of
lot No. 9, S. 27 E. 15.12 chains to stake on Lawton's line; thence with Lawton's line S. 63
W. 3.00 chains to stake corner of lot No. 7; thence with line of lot No. 7, N. 27 W. 15.09
chains to stake on a 20 foot road above mentioned; thence with said road N. 62-1/2 E. 3.00
