at and before the sealing of these presents by *J. Petropoulos*

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said *J. Petropoulos*, All that certain piece, parcel or lot of land situate, lying and being in Chick Spurge Township, Greenville County, State of South Carolina, being a portion of the *E. M. Wharton* sub-division lot near Pacific station in the above County and State - having the following metes and bounds:

Beginning at a stake on Woods Avenue corner lots numbers 57 and 58, running thence N 29-44 W, twenty-five feet to a stake in line said Woods Avenue, from lots numbers 58 and 59, thence S. 60-16 W, eighty feet to a stake corner lots 58 and 59 in line Woods & *E. M. Wharton*, thence S. 29-44 E, in line of lots 58 and lands of *E. M. Wharton*, twenty-five feet to a stake corner lots numbers 58 and 57, thence N 60-16 E, in line of lots 58 and 57, eighty feet to the beginning corner.
