at and before the sealing of these presents by R. L. Ford

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said R. L. Ford all that piece, parcel or lot of land situate, lying and being in the State aforesaid, County aforesaid, near the Town of Greer, in Chick Springs Township, and being a part of lot No. 13 and the same being Cunningham-Humphreys-Burgiss division, as shown by plat made by W. M. Miller Dec. 10, 1915. Being more particularly described as follows: Beginning at a stake in the East line of lot No. 13, said stake standing S. 6 degrees 32 minutes West 24.5 feet from the intersection of an unnamed street with 15 foot alley, and running with the margin of said unnamed street N. 6 degrees 32 minutes East 37 feet to the center of the 15 foot alley; thence with the center of said alley N. 56 degrees 40 minutes West 98 feet to a stake; thence S. 17 degrees West with the West line of lot No. 14, 45 feet to a stake in the center of 15 foot alley; thence with the center of said alley in an eastern direction 98 feet to the beginning.
