(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Robt Ford, all that piece parcel or lot of land situate, lying and being in the State and County aforesaid, near the town of Greer in Chick Springs Township, being a part of lot No. 16 on a plat of the Cunningham-Haysworth-Burgess division, made by W. G. Miller, C. E. on Dec. 10, 1915, Being more particularly described as follows: Beginning at a stake in the east line of lot No. 16 said stake standing S. 17 degrees West 65 feet from the intersection of the east line of lot No. 16 with the center of a 15 foot alley and run with the east line of lot No. 16 N. 17 degrees East 39 feet to a stake in the center of 15 foot alley, thence with the center of said alley N. 56 degrees 40 minutes West 55 feet to a stake, thence S. 17 degrees West with the east line of lot No. 17, 80 feet to a stake in the center of a 15 foot alley, thence with the center of said alley in a westerly direction 55 feet to the beginning.
