KNOW ALL MEN BY THESE PRESENTS, That W. G. Henderson of Greenville County &

in the State aforesaid,
 in consideration of the sum of Five Dollars & other valuable considerations DOLLARS,
 to me in hand paid
 at and before the sealing of these presents by J. C. Milford of County & State aforesaid

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said J. C. Milford all of my right title & interest, which is one half in those two certain lots or parcels of land situated in Greenville County State of S. C. in the Sixth Ward of the City of Greenville and known as lots numbered five (5) and fifteen (15) on plat of the estate of Mrs. G. C. Harris made by W. D. Hives on Oct. 22nd, 1913 & recorded in office R. M. C. in plat Book C at page 261 Lot No 15 fronting on both Edwards and Johnston Sts. Sixty feet with a depth of 110 ft. Lot 205 fronts on Augusta Street (38 1/2) feet fifty-eight & five tenths ft. & on Edwards St (136) one hundred & thirty six feet. Being the lots conveyed to W. G. Henderson & J. C. Milford by Wm. C. Willis & H. H. Harris on the 4th Oct. 1916. Also all of my interest which is one half in that certain lot situated in Greenville County State of S. C. in the Sixth ward of the City of Greenville & has the following courses and distances commencing at a stake joint rear of Henderson & Milford & H. C. Crenshaw thence with former dividing line of said lots S. 65-107 1/2 127.8 ft. to a stake, thence by a new line N 79-00 E. 65.4 ft. to a stake, thence N. 51-30 E 66.1 ft. to the beginning point surveyed by R. Milford & his heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
