WHEREAS, Mrs. S. A. Williams, et al,

on or about the 30th day of June in the year of  
our Lord nineteen hundred and Seventeen exhibited their complaint in the Court of  
Common Pleas, for the County aforesaid, against Frattie J. Earle, et al,

demanding judgment in relation to the real estate hereinafter  
mentioned and described; and the cause being at issue, came on to be heard on the 16th day of October 1917, and such proceedings were had therein as resulted in a decree of the said Court,

for the sum of One Thousand (\$1,000.00) Dollars  
being at that price the highest bidder therefor.

NOW, Therefore, Know all Men by these Presents, that I E. Innman,  
Master in and for the County of Greenville, aforesaid, in consideration of the sum of One Thousand (\$1,000.00) Dollars,  
to me paid by the said R. F. Lenhardt,

the receipt whereof I hereby acknowledge, HAVE GRANDED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said R. F. Lenhardt,

all that piece, parcel and tract of land situated on the north side of the Saluda River, in Paris Mountain Township, County and State aforesaid, and being as portion of tract No 4 of a subdivision of the Rutledge Saluda River Plantation, containing eighty-nine and four-tenths acres, more or less, and more particularly described as follows: Beginning at a post oak, gone, on stone in old road; thence S 36° 27' E 26.04 to a spring, thence S 61° 11' E 21.12, more or less, to a point in the track intersecting the line of the fifteen acres conveyed to A. H. Furman by Frattie J. Earle; thence along that line following the meanderings of Saluda River to the mouth of a branch; thence up the meanderings of said branch to a small stream; thence N 61° 38' E 8.90 to a small fence; thence N 83° E 2.28 to a stone in old road; thence along the said old road N 71° 48' W 9.61 to the beginning corner. One and one-tenth acres is now covered by water and is sold subject to the right of said overflow."
