

Gower Supply Co. DEED TO The Security Investment Co. State of South Carolina, COUNTY OF Greenville

KNOW ALL MEN BY THESE PRESENTS, That Gower Supply Company a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of ten dollars and other valuable considerations

Investment Company a corporation chartered under the laws of the State of South Carolina, and having its principal place of business at Greenville, in the State of South Carolina and its successors and assigns, all that certain lot, piece or parcel of land, situate lying and being in the State of South Carolina and County of Greenville, in the Fourth Ward of the City of Greenville; having the following metes and bounds, to-wit: Beginning at an iron pin 3 1/2" corner Broad and Gas streets, and running thence with line of Broad Street S. 69 1/2° E. one hundred and eighty-seven (187) feet to a stake 3 1/2" corner of lot of land now belonging to Southern Public Utilities Company (formerly belonging to S.P.C. and S.M. Gower); thence with line of last mentioned lot N. 20 1/4° E. one hundred and thirty-four (134) feet to a stake 3 1/2" on line of Charleston and Western Carolina Railway; thence along and with line of said railroad property N. 70° W. two hundred and twenty-five (225) feet to an iron pin 3 1/2" on Gas Street; thence along and with Gas Street S. 4° W. one hundred and thirty-eight (138) feet to the beginning corner, containing twenty-seven thousand six hundred and four (27604) square feet, more or less, and being the same land conveyed by A. H. Gower and W. L. Spreight to Gower Supply Company, by deed dated July 21, 1902, and recorded in the office of the Register of Merce County for said County and State in Volume S. D. L. page 803. Paris Mountain Summer Home Co. DEED TO Paris Mountain Company, State of South Carolina, COUNTY OF Greenville

KNOW ALL MEN BY THESE PRESENTS, That Paris Mountain Summer Home Company, a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Three Thousand Three Hundred DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto Paris Mountain

Company, all that piece parcel or lot of land in Paris Mountain Township, Greenville County, State of South Carolina, containing one hundred fifteen and 57/100 acres, more or less, except such portions as have been sold off, the main tract having the following boundaries: Beginning at a stone on the road from Hillholce Mt. to Thompson's Mt. and running thence N. 28° E. 5.90 to a chestnut oak; thence N. 47 3/4° E. 41.25 to a pine; thence N. 42 1/4° W. 18.50 to a stone; thence S. 47 3/4° N. 53.90 to a stone; thence S. 12 1/2° E. 12.50 to a stone; thence N. 86 1/2° E. 17.00 to the beginning. Being the same tract conveyed by George W. Marchbanks and others to S. W. Irvine September 29th 1885, and recorded in Book R. P. page 19.

Certain small lots were conveyed from the main tract prior to January 6, 1914, and these are excluded. For a description of such lots which are not intended to be covered by this deed reference is had to books of record in the office of the Register of Merce County conveyance for Greenville County. The property hereby conveyed is the same conveyed to Paris Mountain Summer Home Company by George W. Irvine and others on January 6, 1914, deed recorded in Book 20, at page 159. Other interests have been conveyed to the corporation since that date.

The corporation has not conveyed any part of the said tract to any person, and by this deed of conveyance, the corporation parts with all of the property on Paris Mountain, which it ever acquired.
