those certain lots or parcels of land situate in the state of South Carolina, Greenville county, tract #95 on Plat 2 property of Parker Land Company surveyed by S. Bedell dated April 14th, Beginning at a point in the center of the new Poor-house road in the line of tract #96 and the N.E. corner of tract #88, hence thence with the center of the said road the following courses and distances N. 2-30 W. 2-07 chaine, N. 4-45 E. 7-11 chs. to a point in the Lipscomb line, the N.W. corner of tract #98, thence with the north boundary of the Parker Land Co. tracts N. 5-4-30 W. 7-40 chaine, to a point in the center of the East fork of the Poor-house branch (rock corner on the west bank) the N.E. corner of tract #94 the line with the center of the said stream and the line of tract #94 the following courses and distances S. 19-57 W. 1-95 chaine, S. 23-39 W. 2-10 chs. 
