KNOW ALL MEN BY THESE PRESENTS, That *Anna R. Sherman* of the City
and County of Greenville

in the State aforesaid,
in consideration of the sum of
One dollar and exchange of other property of equal value DOLLARS,
to *J. M. Steele* in hand paid
at a time to be hereinafter specified, in hand paid
at and before the sealing of these presents by *Sarah E. Barnes*.

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said
Sarah E. Barnes and her heirs and assigns, all that
certain lot, piece or parcel of land situate, lying and
being in the State of South Carolina and County of
Greenville, in the fifth Ward of the City of Greenville,
having the following metes and bounds, to-wit:
Beginning at a stake on the north side of Perry
Avenue, on the south-west corner of a lot of land
conveyed by me, the said Anna R. Sherman, to
J. G. Steele by deed recorded in the office of the
Register of Deeds Conveyances for said County
and State in Deed Book No. 36, at page 38, and running
thence along line of the said Steele lot N. 18° E.
one hundred and seventy-three (173) feet, more or less,
to a stake on line of lot conveyed by me to L. L.
Barr by a deed recorded in said office in Deed
Book No. 10, at page 367; thence along line of last
mentioned lot N. 71° W. forty-five and a half (45½) feet
more or less, to an iron pin on one of the corners
of the said Barr lot; thence still along line of said
Barr lot S. 19° W. one hundred and seventy-three (173)
feet to an iron pin on Perry Avenue; thence with
the said Perry Avenue S. 41° E. forty-five and a
half (45½) feet, more or less, to the beginning corner,
thus being a portion of the lot of land conveyed by
J. Thomas C. Gower and William C. Earle to Henry
Fiedner by deed bearing date November 15, 1877,
and recorded in said office in Deed Book 20
at page 340; this being all of said lot which now
belongs to me; the remainder thereof being sold to
various persons at various times, as will appear
by reference to the recitals contained in my said
Deed to L. L. Barr, recorded in Deed Book 10, page 367.

heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said *Sarah E. Barnes* and her

heirs and assigns, against

myself and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
