KNOW ALL MEN BY THESE PRESENTS, That C. A. Fowler of Greenville County

in the State aforesaid,
 in consideration of the sum of
Twenty two hundred and eighty DOLLARS,
 to me in hand paid
 at and before the sealing of these presents by W. H. Burrell

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said

W. H. Burrell, all that piece parcel or tract of land situate lying and being in the state and County aforesaid on both sides of Long Branch, waters of South River Beginning at a stone 370m on the north side of Long Branch (Mrs Rebecca Brawlett corner) thence S 12 E 45 rods to a stone 37 7/8 m thence Easterly 18 rods more or less to a stone 37 7/8 m thence northerly 42 rods and ten feet to a stone 3 x 0 m Rebecca Brawlett line at or near the fork of the road thence S 89 W seven rods and ten feet to the beginning corner containing three (3/4) and one half acres, more or less, adjoining lands of Rebecca Brawlett, being the same tract of land conveyed to me by J.
