Eppes Jordan and described as follows: Beginning at a stake on the Coker line, thence N. 53° 1/4 E. 9.07 to rock, thence N. 46° 1/2 W. 12.40 to stake on Cooley line, thence S. 53 1/4 W. 8.90 to a stake, thence S. 46 E. 12.44 to the beginning corner. A right-of-way for a road on the line of lots no. 1, 2, and 5 from lot no. 3 to the Peltzer road is reserved.
