Maxwell by Will D. Nevel, Eng. Sept. 22, 1913, and described as follows: Beginning at an iron pin 3 1/2 on the west side of Stratham Street and the north side and 3 1/2 of an alley, and run thence with said Stratham Street N. 0. 15 E. 319.7 feet to an iron pin 3 1/2 on the west side of Street, thence N. 85. 30 W. 181. 2 feet to an iron pin 3 1/2; thence S. 56. 30 W. 30. 5 feet to an iron pin 3 1/2, the second 3 1/2 of lot No. 1; thence S. 12. 20 E. 322. 9 feet to an iron pin 3 1/2 on the north side of an alley, thence with line of said alley N. 89. E. 136. 6 feet to the beginning corner, and is bounded by lands of late Nov. 1 and 2, Mrs. E. S. Smith, Jno. Taylor and Stratham Street and others.
