KNOW ALL MEN BY THESE PRESENTS, That J. J. Henry of the County of Greenville, State of South Carolina

in the State aforesaid,
 in consideration of the sum of Ten (\$10.00) Dollars and other valuable considerations DOLLARS,
 to me in hand paid
 at and before the sealing of these presents by J. T. Mahaffey

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said

J. T. Mahaffey, all that certain piece, parcel or lot of land situate lying and being in the County of Greenville State of South Carolina, being lot no. 12 of Cherokee Park, according to a plat recorded in R. M. C. Office for said County and State in Plat book "C", page 26, said lot, having the following metes and bounds to wit: Beginning at corner of lot no. 11, five hundred eighty three (583) feet and nine (9") inches from Augusta Road on Conestee Avenue, and running thence N. 62.32 W. 169 1/2 feet to an alley; thence along said alley S. 27.58 W. 60 feet to corner of lot no. 13; thence S. 62.32 E. 170 feet along line of lot no. 13, to Conestee Avenue; thence with Conestee Avenue N. 27.58 E. 60 feet to the beginning corner, said lot being a part of the land conveyed to the Cherokee Land Company by D. O. Patterson by deed recorded in Vol. 21, page 574, and being same lot conveyed to me by said Cherokee Land Company by deed dated Mar. 30, 1916 and recorded in R. M. C. Office for Greenville County, and subject to the provisions and together with the rights and privileges recited in said deed.

As a part of the consideration for this deed, Grantor herein agrees to and does hereby assume the note and mortgage for the sum of Two Hundred and Fifty (\$250.00) Dollars and interest from date of same, given by Grantor herein to E. Bertrude Barnes on the above described lot of land, dated March 31, 1916 and recorded in R. M. C. Office for Greenville County in Vol. 52 page 134

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said

J. T. Mahaffey, his heirs and assigns, forever.

Subject, however to the provisions and together with the rights and privileges recited in a deed covering said lot no. 12, to Grantor herein by Cherokee Land Company by deed dated Mar. 30th, 1916, providing no dwelling house or store shall be built on said lot costing less than \$1500 and no persons of African descent shall enter or occupy said lot, which are conditions, subsequent

myself, my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said

J. T. Mahaffey, his heirs and assigns, against

heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
