KNOW ALL MEN BY THESE PRESENTS, That

I, W. L. Garrett,

in the State aforesaid,
Ten Dollars and other valuable considerations DOLLARS,
to me
in hand paid
at and before the sealing of these presents by Bessie A. Tucker!

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said Bessie A. Tucker her heirs and assigns! All that certain lot of land situate in the City of Greenville in County & State aforesaid. Known as lot #18 of Block D. Eagle Park as shown on Plat recorded in C. M. C. Office for Greenville County in that Book C. page 228 where particularly described as follows:
Beginning at corner pin on Precincts Ave corner lots #19 and running thence with Precincts Ave S. 66-09 E. 60 ft. to iron pipe corner lot #17 thence with line of lot #17 S. 38-30 W. 150.1 to iron pipe, in a wavy line with said Alley N. 73-32 W. 36-71 ft. thence with said Alley N. 73-32 W. 22 ft. to iron pipe corner lot #19 thence with line of lot #19 N. 32-12 E. 157-1 to beginning corner of subject however to the following restrictions which are part of the considerations for this deed and are made for the benefit and protection of the other lots shown on the plat above referred to, which restrictions shall remain effective for a period of twenty years from the date of this deed to all 1st: This property herein conveyed may any part thereof shall not be sold rented or otherwise disposed of to negroes.
2nd: The said property shall not be used for any unlawful business nor for anything which would constitute a nuisance.
3rd: The property herein conveyed shall not be resold nor subdivided so as to face any other direction than as shown on said plat.
4 - No building shall be erected upon said property within 25 feet of the present fence of William A. W. 5 - No building costing less than \$25,000.00 shall be erected upon said lot other than appurtenant to a dwelling.
"It is agreed and understood that as part of purchase price consideration of above described lot that the grantee assumes, and agrees to pay a note secured by mortgage on within described lot for the sum of twelve hundred & seventy five dollars (\$1275.00) for term of one year, interest from 1st day of April 1919 at rate of six (6%) percent per annum, said note being given by grantor W. L. Garrett to Eagle Park Co.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining, TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said Bessie A. Tucker, her heirs and assigns, forever.
