

Ira L. Grizzini DEED TO *J.R. Owens*

 KNOW ALL MEN BY THESE PRESENTS, That *I Ira L. Grizzini of the County of Greenville*

in the State aforesaid,
 in consideration of the sum of *Eighteen Hundred (1100)* DOLLARS,
 to *me* in hand paid
 at and before the sealing of these presents by *J.R. Owens*

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said

J.R. Owens, his heirs and assigns forever. All that certain lot of land situate in the 16th Ward of the City of Greenville, County of Greenville, State of South Carolina, known and designated as lot #7 of Block B of Eagle Park as shown on Plat recorded R. M. C. Office for Greenville County, Plat Book 6 page 238 and having the following metes and bounds, to wit: Beginning at an iron pipe on the north side of Mills Avenue, corner of lot #8 and running thence with line of lot #8 N. 15 W. 186.8 feet to an iron pipe thence S. 73-01 W. 88 feet to an iron pipe corner of lot #6 thence with line of lot no. 6 S. 21-44 E. 180 feet to iron pipe on Mills Avenue thence with Mills Avenue N. 79. 12 E. 67 feet to the beginning corner.

Subject, however to, the following restrictions, which are part of the consideration for this deed, and are made for the benefit and protection of the other lots shown on the plat above referred to, which restrictions shall remain effective for a period of twenty years from July 3, 1916 to wit: (1) The property herein conveyed nor any part thereof shall not be sold, rented, or otherwise disposed of to negroes (2) The said property shall not be used for any unlawful business nor for anything which would constitute a nuisance (3) The property herein conveyed shall not be recut, nor sub-divided so as to face any other direction than as shown on said plat. (4) No building shall be erected upon said property within 25 feet of the present line of Mills Avenue (5) No building costing less than \$3,500.00 shall be erected upon said lot other than out buildings appurtenant to a dwelling.

And subject to mortgage given August 21, 1919 by *Ira L. Grizzini to Rudolf Anderson*, recorded in R. M. C. Office for said County and State in Book 79 page 33, for the sum of two thousand dollars, which mortgage the said *J.R. Owens*, hereby assumes.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining, TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said *J.R. Owens, his* heirs and assigns, forever.

AND *I myself and my* heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said *J.R. Owens, his*

heirs and assigns, against *me* and *my* heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
