DEED TO *O. B. Bennett et al.*

KNOW ALL MEN BY THESE PRESENTS, That *The Emma J. Whilden and Ella Mauldin of the County of Greenville and*

*in the State aforesaid,* in consideration of the sum of *Two Thousand One Hundred (\$2100.00) and no 100 DOLLARS,* to *O. B. Bennett and O. J. Bennett* in hand paid

at and before the sealing of these presents by *O. B. Bennett and O. J. Bennett*

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said *O. B. Bennett and O. J. Bennett and their heirs and assigns, forever, all that certain piece, parcel or lot of land situate lying and being in Ward Five of the City of Greenville County of Greenville and State of South Carolina, on the North side of Perry Avenue, and having the following described metes and bounds, to wit: Beginning at a point on the North side of said Perry Avenue 112 feet from the east corner of said Perry Avenue and Leach Street, thence in an Easterly direction, along and with the street line of said Perry Avenue, a distance of sixty feet, thence at right angle with the said street line, in a Northerly direction, one hundred and eighty feet to an Alley, as shown on a plat of the said property, which said plat is recorded in the Office of the R. M. C. for Said County; thence in a Westerly direction, along and with the Alley, a distance of sixty feet, thence in a Southerly direction, a distance of one hundred and eighty feet to the beginning point.*

*This is lot No. 5 as shown on the above plat which plat is recorded in Plat Book C, page 171.*

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining, TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said

*O. B. Bennett and O. J. Bennett and their*

heirs and assigns, forever.

Subject however to the full and distinct understanding between the parties to this deed, that it is a part of the consideration hereof, that the Grantees are to assume and pay all unpaid pauperages on the said lot, not to exceed the sum of Fifty Dollars, and that they or either of them are to construct a dwelling house on the said lot within one year from the date of this deed, said dwelling house to cost not less than Five Thousand dollars nor built nearer than twenty-five feet to the street line of the said Perry Avenue.

AND we do hereby bind ourselves and our

heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said
