(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said

E. M. C. Flinkingshelt, her heirs and assigns, all that certain parcel and tract of land situate, lying and being in the County and State aforesaid about one and one-half miles from Greenville, Court House, on the Laurens Road, and having the following meters and bounds as shown on plat made by R. E. Dalton, Engineer of the property of W. H. Irvine, Bankrupt, dated day, A. D. 1917, to wit: Beginning at an iron pin, or pipe on Laurens Road, corner of W. P. Mc Kee's land and running thence with the Laurens Road S. 55-16 E. 44.7-2 feet to an iron pin on the Laurens Road, corner of the Holcombe property, thence with the line of Holcombe property, N. 64-55 E. 97.8 feet across to the C. railroad to an iron pipe, corner on Holcombe property, thence with Holcombe property and other property of said W. H. Irvine's estate N. 36-05 W. 18.78 feet to stone on Road, thence with property of R. P. Mc Kee S. 30-50 W. 65.0 feet to an iron pin on C. & W. C.
