being in the County and State aforesaid, located in what is known as the
Cagle Park Property, and being more or less Lot 15 of Block D, as shown on a
plat of the Cagle Park, recorded in R. M. C. Office for Greenville County.
Also all that certain piece, parcel and lot of land, situate, lying and
being in the County and State aforesaid, located in what is known as the
Cagle Park Property, and being more or less Lot 16 of Block D, as shown on a plat
of the Cagle Park Company, recorded in R. M. C. Office for Greenville County.

The above lots are partially within and partially without the City of Greenville
and are described as follows: Beginning at a stake on the West side of Pin-
tress Avenue 61.5 feet from the West side of a lane, which leads from Aug-
usta Road to Crescent Avenue; and running thence with said Pinress Ave-
