Cleveland, by R. E. Dalton, Engineer, dated October, 1919 to wit: Beginning at an iron pin on Pendleton Street, Southern corner, and running thence with line of W. J. Southern 22.18 27.8 167.5 feet to an iron pipe of 1.17 58 157.3 feet to an iron pipe on Pendleton Street; thence with Pendleton Street 865.08 E. 100 feet to the point of beginning.
