Twenty-one (21) feet to a drill hole in the sidewalk; thence N. 69.30 E. one hundred (100) feet with line of lot no. 10 of said plat to an iron pin in an alley; thence, with said alley N. 28.55 E. twenty-one (21) feet to an iron pin; thence S. 69.30 E. one hundred (100) feet with line of lot no. 8 to the beginning corner, and known as lot no. 9 on the plat made by E.
