(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

J. F. Spence, his heirs and assigns forever: all of that tract of land in the town of Piedmont, County and State aforesaid on the West side of the S. S. Railroad, being part of the tract conveyed to me by P. L. McDavid by Deed dated April 29, 1918 recorded in the office of R. M. C. for Greenville County, S.C. in book 14 page 213 and being part of the lot or tract of land previously owned by S. T. and Aletha Smith, Emma Lee Jones, W. B. Jones, C. C. Waldrep and J. G. Craymer successively, the portion of the tract herein conveyed being described as follows, in plat made by Wm. F. Lee, Surveyor, from Survey of November 23, 1919: Beginning at iron stake N. 37° 69' 2" W. 3.50 to center of Piedmont road; thence with said road S. 13° 41' 3.20 iron Stake S. 40' 2" E. 4.86 iron stake; N. 8° 3' W. 3.43 to beginning, containing one and one-fourth ($\frac{1}{4}$) acres, more or less.
