Walker Co. et al. successors and assigns, All that certain lot of land, situate in the City of Greenville, in the County and State aforesaid, known and designated as lot no. 7 of Block C, of Cagle Park, as shown on plat recorded in the R. M. C. office for Greenville County, in Plat Book C, page 238, and being more particularly described as follows; Beginning at iron pipe on the north side of Prentiss Avenue, at corner of lot no. 8, and running thence with line of lot no. 8 N. 25-20 W. 158.6 ft. to iron pipe thence with line of lot no. 10 S. 86-03 W. 158.6 ft. to iron pipe corner of lot no. 6 thence with line of lot no. 6 S. 29-46 E. 158.9 ft. to iron pipe on Prentiss Avenue thence with Prentiss Avenue, along a curved line, cord of which is S. 89-58 E. 64 ft. to the beginning corner.
