(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

R. A. Southerlin, his heirs and assigns forever all those certain pieces, parcels or lots of land situated, lying and being in the County and State aforesaid, about three miles from Greenville County Courthouse, in section known as "City View" and being known and designated as lots Nos. 4 and 4A, according to a plat of said lots as shown in Plat Book "B" page 112 and having the following courses and distances, to wit;

Beginning at a stake, joint corners of lots 3 and 4, and running thence in a southerly direction with said joint lines 296 feet to a stake at Sheppards corner, thence with said line 30 feet to a stake; thence in a northerly direction 296 feet and 10 inches to a stake on O'Neal line. Thence with said line in a westerly direction 114 feet to the beginning corner and being the same lots of land conveyed to me by A. C. Lee by deed datd March 27th, 1919, which deed is recorded in the R. M. O. Office for Greenville County in Book Vol. 44 page 475.
