(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

H. R. McKey All that piece parcel a lot of land in Greenville Township, Greenville County, state of South Carolina, in the City of Greenville on Stone Avenue and described as follows:

Beginning at an iron pin on the north side of Stone Avenue sixty-five and one half feet ($65\frac{1}{2}$) feet from the Northwest corner of Stone Avenue and Brown's Street, Remmells corner and running thence which Remmells Line $7\frac{1}{2}$ is two hundred (200) feet to an iron pin, thence $8\frac{1}{2}$ feet, thence $8\frac{1}{2}$ W. sixty-five and one-half ($65\frac{1}{2}$) feet to an iron pin, thence $8\frac{1}{2}$ feet hundred (100) feet to a stake, thence $8\frac{1}{2}$ E. sixty-five and one-half feet ($65\frac{1}{2}$) to the beginning corner.
