AND I do hereby bind myself and my heirs, executors and administrators to warrant and forever defend all and singular the said premises unto the said O. H. Drew & Lucile Drew their heirs and assigns against myself and my heirs and every other person whomsoever lawfully claiming, or to claim, the same or any part thereof.
