in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said Southern Motor Company of Greenville, its successors and assigns,

all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina. on the East side of South Main street, and described as follows: - Beginning at a point on the East side of said Street at the corner of lot conveyed by Rowley and Miller to C. J. and J. N. Morgan Jr. and runs thence with it S. 44 E. 16 1/2 feet, thence with rear line of said Morgan lot S. 16 W. 22 feet easterly, thence with the Southern line of lot conveyed by Gower to Rowley and Miller S. 44 E. 16 1/2 feet more or less, thence with rear line of lot conveyed by Gower to Rowley and Miller N. 16 E. approximately 78 feet 3 inches to the Southeastern corner of lot conveyed by Rowley and Miller to Floyd and Merchant; thence with line of said Floyd and Merchant lot N. 44 W. 17 1/2 feet to Main street; thence with Main St. S. 16 W. approximately 56 feet final to the beginning subject to the interest in the southern wall conveyed by Rowley and Miller to C.
