Johnson*, the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said *W. T. Johnson, his heirs and assigns forever,*

The following described real estate, to wit: All that certain piece parcel or tract of land containing three and 7/10 (3-7/10) acres, more or less, situated, lying and being in the County and State aforesaid, about three miles from Greenville Court House, adjoining lands of Craft, Bradley, Sum and Jenkins, Beginning on a Red Oak stump and running thence S. 78 1/2 E. 5. 25 to a stone on old line; thence N. 8. 4 E. 5. 46 to a stone in old road; thence with said road N. 73 1/2 W. 18 to a stone on the road; thence S. 8 1/2 E. 6. 50 to the beginning corner.
