the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said.

P. C. Bower and his heirs and assigns forever, the following described real estate;
"All that piece parcel and lot of land situate lying and being within the corporate limits of the City of Greenville, and having the following metes and bounds and courses and distances, to-wit: Beginning at stake on Washington St. and Mrs. Earle's corner, and running thence with Washington St. N. 66 1/2 W. 76 feet to a stake, thence S. 23 1/2 W. 217 1/2 feet to stake, thence S. 66 1/2 E. 76 feet to stake on Mrs. Earle's corner, thence with Mrs. Earle's line, N. 23 1/2 E. 217 1/2 feet to the beginning corner."
