the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said.

R. J. Croskeys, the following described real estate; "All that piece, parcel or lot of land situate, lying and being in the City of Greenville, and in the State and County aforesaid, on the corner of Leach and Barnwell Streets, and is the eastern half of what was formerly known as Lot no. 2 on a plat of the Mountain City Land and Improvement Company, and having the following metes and bounds, courses and distances: Beginning at a point on Leach Street 67 feet north of the corner of Leach and Barnwell Streets, and running S. 18 1/2 W. 67 feet to corner of said Leach and Barnwell Streets; thence along Barnwell Street, N. 76 - 2/3 W. 75 feet to a stake; thence in a line parallel to Leach St. N. 18 1/2 E. 67 feet to stake; thence in a line parallel to Barnwell Street, S. 76 2/3 E. 75 feet to the beginning point on Leach Street; this is the same lot conveyed to Eugene S.
