the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release  
unto the said.

W. M. Chamblee, the following described real estate:

"All that lot of land situate in the Town of Fountain Inn, in the County  
and State aforesaid, on the east side of Fowler Street, bounded on the North by lands  
of Mrs. J. M. Stokes; on the East by lands of B. L. Holland; on the South by lands of  
Bob Thomason; on the West by Fowler street, containing one and one fourth (1 $\frac{1}{4}$ ) acres,  
more or less.

Also, all that certain lot or tract of land situate in the State and  
County aforesaid, west of and about one mile from the center of the Town of Fountain  
Inn, bounded on the West by Babb Street; on the North by lands formerly of the Sprouse  
Estate, now of Sam Drummond; on the West by the Old Fairview Road and on the South by
