The Lessors shall at all times have the right to enter upon said premises for the purpose of inspection thereof. Should any instalment of the rental hereinabove reserved be in arrears for more than thirty (30) adays, the Lessors mag at their option declare this lease terminated and enter upon and take possession of the said premises without notice or legal process.

Should the Lessees violate any of the covenants above set forth the Lessors may, after five (5) days notice, terminate this lease and enter upon and take possession of said premises without legal process.
