Poore, for and in consideration of the premises and of the sum of five hundred dollars (\$500.00) heretofore paid unto me by the said Pearl Payseur Poore, as recited in said deed (receipt is hereby re-acknowledged) have remised, confirmed, granted, bargained, sold and release, and by these presents do remise, confirm, grant, bargain, sell and release, unto the said Pearl Payseur Poore, her heirs and assigns, forever; All my right, title and interest (said interest being an undivided one-fifth thereof) in and to all the real estate of which my father, J.W. Poore, died, seized and possessed, including all of the real estate of which my said father died seized and possessed, situate in and near the town of Belton, County of Anderson, State of South Carolina, and a tract of land consisting of thirty-five (35) acres, more or less, on Saluda River in Dunklin Township, County of Greenville, State of South Carolina, adjoining lands now or formerly owned by John E. Smith, Robert Epps and Belton Power Company and of which my said father was also seized and possessed at his death. Said real- estate situate in said town of Belton includes a lot more fully described es follows:

All that certain piece, parcel or lot of land situate, in the Town of Belton, County of Anderson State of South Carolina, containing One acre, more or less, and more particularly described as follows: Beginning at an imon stake at the southeastern corner of said lot where it intersects with lot of the First Baptist Church, thence westewardly five hundred and five (505) feet to an iron stake; thence northerly one hundred and fifty (150) feet to an iron stake on boundary line of lot owned by Mrs. - - Bowen; thence Eastwardly four hundred and three (403) feet to iron stake on Brown Avenue; thence southerly along the said Brown Avenue eighty-three (83) feet to the beginning point; said real estate fronting eighty-three (83) feet on the said Brown Avenue and adjoining lands of Herman Poore, the said First Baptist Church and others.
