Norwood property and beginning at an iron pin corner of said lot and the Catholic Church property, and on the North side of West Washington Street, running thence along the Catholic Church property line one hundred (100) feet to an iron pin; thence along line parallel with West Washington Street twenty (20) feet to joint corner of lots Nos. 1 and 2; thence along joint line of lots Nos. 1 and 2, one hundred (100) feet to West Washington Street; thence along West Washington Street, twenty (20) feet to the beginning corner, reference being craved to plat of W.D. Neves, Engineer, dated May 24, 1920.
