demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to be heard on the 19th day of December 1921, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. All that certain piece parcel or lot of land situated in Chick Springs Township, County of Greenville, and State of South Carolina, and in the Town of Taylors, and being known and designated as Lot No. 29, on a subdivision of Lot No. 2, property of W. M. Shockley, deceased, as shown by subdivision and Plat of same made by Thos. J. Linder, Nov. 10, 1921, and recorded in the R. M. C. Office for the County and State aforesaid, in Plat Book "9" at page 20. This lot contains 1 acre and has a frontage on the Public Road of 1.58 chs. and runs back in parallel lines 6.35 chs. and has a rear line of 1.58 chs. along line of Lot No. 34.
Reference is hereby craved to the plat above referred to for a more particular description of said lot.
