demanding relief as to the real estate described in the complaint; and the cause being at issue, came on to be heard on the 19th day of December 1921, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. NOW, Therefore, Know all Men by these Presents, that I, E. Suman Master, in and for the County of Greenville aforesaid, by virtue of the aforesaid decree, and upon receipt of \$2580.00 HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said _____

A. W. Walker and his heirs and assigns forever, the following described real estate:
"All those certain pieces, parcels or lots of land situated in Chick Springs Township, County of Greenville, and State of South Carolina, and in the Town of Taylors, and being known and designated as lots Nos. 32 and 33 on a subdivision of Lot No. 2 property of W.M. Shockley, deceased, as shown by subdivision and plat of same made by Thos. T. Linder, Nov. 10, 1921 and recorded in the R.M.C. Office for the County and State aforesaid, in Plat Book F., at page 45. Lot No. 32 contains 12.74 acres and is more particularly described as follows: Beginning at the southwest corner of Lot No. 31 and running thence S. 1-1/2 W. 6.88 along the line of Lot 28, to the northwest corner of Lot 33; thence along the line of last mentioned lot S. 86 E. 14.20 to pine; thence N. 63-1/4 E. 6.75 to stone; thence N. 1 W. 3.53 to the southeast corner of lot 34; thence along the lines of lots 34 and 31, N. 86 W. 19.95 to the beginning corner. Lot No. 33, contains 12.50 acres and is described as follows: Beginning at the southwest corner of lot 32 and running thence S. 1-1/2 W. 4.85 to line Perry Edwards land; thence S. 70-3/4 E. 11.35 to stone; thence S. 38-3/4 E. 3.02 to stone; thence N. 33 E. 11.24 to stone; thence N. 38 E. 3.60 to stone; thence 60 links to corner of lot 32; thence along the line of last mentioned lot S. 63-1/4 W. 6.75 to pine; thence N. 86 W. 14.20 to the beginning corner."
