Furman, Jr., Civil Engineer, December 18, 1922 to-wit: Beginning at the corner of lot of William Donald, Sr. and running thence along the line of Greene Ave, N. 26-45 E. to corner of lot sold to R. H. Hellams; thence along the line of the Hellams lot S. 62.10 C. 177.75 feet to Cross Kuyd Alley; thence along the line of said Alley S. 26.35 W. 64 feet to the corner of lot of William Donald Sr. thence along the line of the Donald lot N. 62.10 W. 177.75 feet to the beginning corner.
