Beginning at an iron sun on Stone Avenue, joint corner between lots nos. 14 and 15, and running thence N. 2° 0' E. 18 ft. to an iron sun in back line of lot no. 15; thence N. 84° 19' W. 28' 5" to an iron sun in the Western line of lot no. 12; thence S. 2° 26' W. 15' 4" to an iron pin; thence N. 84° 19' W. 3' to an iron sun corner lots nos. 13 and 14; thence S. 2° 26' W. 16' 9 5" to an iron pin on Stone Ave corner lots nos. 13 and 14, thence along Stone Avenue S. 83° 17' W. 60 feet to the beginning corner.
