Morgan, his heirs and assigns, All that lot of land situated at the northwest corner of Broadway Avenue and Pettigrew Avenue, in the City and County of Greenville South Carolina, and described as follows: Beginning at ran 2 in the sidewalk at the northwest corner of Broadway Avenue and Pettigrew Street, and rune thence with said Avenue N. 14.45 W. 117.7 feet to an iron pin at the corner of the A. W. Smith property, thence with the line S. 73.00 W. 174.5 feet to an iron pin in a bend of the South property, thence continuing with the line S. 10.15 W. 26 feet to an iron pin in the Christ Church property, thence with the Christ Church property line S. 11.00 E. 162.9 feet to an iron pin on Pettigrew Street thence with said Street N. 65.45 E. 203.5 feet to the southeast corner being the same land conveyed to me by Adger Smith, by deed dated the 17th day of July, 1920, and recorded in Vol. 48, page 411.
