(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

W.D. Warkman, his heirs and assigns:

All my right, title, and interest,
the same being an undivided one-half interest in the said lot,
all that certain lot No. 1, each situated in the City of Greenville
County and State aforesaid, on the south side of East
Court Street, being lot No. 1 on that made by H. C. Dalton
Engineer, December 1919, and having the following outer
and boundary to wit: Beginning at a point corner of
said lot at the intersection of East Court street
and a court square with line of East Court street
6.71-39' 6.101 feet and four inches to a point at the N.W.
corner of no lot alley, thence with line of said alley
3.17-42' 11.54 feet backwya to a point in line of lot No. 1
thence with line of said lot 31.70-55' 24.101 feet 2 inches
to a point in back line; thence 31.17-33' 6.53 feet 2 $\frac{1}{2}$
inches to the beginning corner.

Also the strip of land commencing at the N.E.
corner of said lot returning thence with the North
line in an easterly direction 5 feet to a point
thence parallel with the east line of said lot 54 feet
backed to a point in line of lot No. 1; thence westerly
with said line to the S.E. corner of lot No. 1; thence with
said line in a northerly direction 54 feet 6 inches to
the beginning corner. It is a condition of this
deed that the said alley be kept open as an alley
for the use of the owners of the adjoining property
covered by said plat.

As a part of the consideration hereinabove
expressed the grantee herein, W.D. Warkman, expressly
assumes and promises to pay a certain note secured
by a mortgage on the above described premises
executed by W.D. Warkman and J.P. Ablee to S. H. Norwood
in the sum of \$58,539.17 together with interest from
date of execution until paid.

W.D. Warkman is to be entitled to all rents
for the year 1920 and is to pay all taxes, insurance,
and other expenses for 1920.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining,
TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said *W.D. Warkman*, his
heirs and assigns, forever.

AND *I*
myself, my
heirs, executors and administrators to warrant and forever defend, all and singular, the said premises unto the said *W.D. Warkman*, his
heirs and assigns, against
my
heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
