A certain piece, parcel or lot of land in Greenville Township, County of Greenville, State of South Carolina, in the City of Greenville, north west corner of Earle and Elizabeth Streets having the following boundaries, Beginning at the afore-said corner, and running thence with the West side of Elizabeth Street North 18-30 East one hundred and ninety-nine feet and three inches (199'3") to a stake at the corner of Earle Street; thence with Earle Street North 66-15 West approximately sixty-four (64) feet to line of lot No. 7 as shown on plat mentioned below; thence with line of said lot South 18-30 West approximately two hundred and six (206) feet to the North of Earle Street; thence with the North side of Earle Street, South 71-20 East sixty-three feet and ten inches (63'10") to the beginning corner, being known as lot No. 8, Section 7, on plat made by J.
