*J. S. Morris*  
All that certain piece, parcel or lot of land situate, being and being in the County and State aforesaid, in a subdivision known as "City View" according to a plat of property of W. P. Conyers and R. L. Simmons, dated January 30th, 1913, by F. Y. Rogers, Engineer and being known and designated as lot No. 1 and having the following metes and bounds - to wit: -

Beginning at an iron pin on Parker Avenue 57'8" from the intersection of Parker Avenue and Center Street front corner of lots Nos. 1 and 2, and running thence with line of lot No. 2, S. 86-30 W. 140'0" to an iron pin on line of lot No. 3; thence with said line of lot No. 3 S. 12-45 E. 64'3" to an iron pin on Center Street; thence with Center Street N. 83-30 E. 140'0" to an iron pin corner Center Street and Parker Avenue; thence with Parker Avenue N. 12-45 W. 57'8" feet to the point of beginning.

Being the same lot of land conveyed to me by Simmons Realty Company, a corporation chartered under the laws of the State of South Carolina, by deed dated October 25th, 1919, and recorded in the P. M. C. Office for Greenville County, in Vol. 53 page 348.

Subject however to the mortgage heretofore executed on the 25th day of October, 1919, by the said J. B. Holcombe to Simmons Realty Company, to secure the sum of \$633.35 with interest thereon from October 25th, 1920 at eight percent per annum, payable annually. Said mortgage being recorded in the P. M. C. Office for Greenville County, in Vol. 88 page 15. It is mutually agreed between the parties hereto that the grantee herein as part of the consideration for this deed does hereby assume the payment of said mortgage debt.
