All the following lots of land in the city of Greenville, County and State aforesaid:  
(1) That certain lot on Green Avenue, beginning at an iron pin on Green Avenue, corner of lot formerly owned by Emma T. Watson, and running thence with said Emma T. Watson's line S. 72 E. 150 ft. to an iron pin; thence S. 28 W. 64 feet to an iron pin; thence N. 72 W. 150 ft. to an iron pin on Green Avenue, corner of lot formerly belonging to Francis W. Bailey; thence with Green Avenue N. 28 E. 64 feet to the beginning corner, being the same lot of land conveyed to Mattie A. McGehee by H. C. Franklin by deed dated April 7, 1906, and recorded in vol. 77, at Page 172.  
(2) That certain lot on Vardry street, south side, beginning at a stake 3x on corner of lot formerly owned by Darwin Gibbons, and now a part of the McGehee estate, thence along line of said lot 410 feet to a stake 3x on Arlington Avenue, thence with said Arlington Avenue S. 73 E. 200 feet to a stake 3x; thence S. 47 W. 410 feet to a stake on Vardry street, thence with said street N. 74 W. 200 feet to the beginning corner, containing 1.74 acres more or less, being the same place of J.
