Beginning at a point on the east side of Hudson Street, north of and 50 feet distant from W. C. Gibson's northwest corner, and running thence in an easterly direction, parallel with said 50 feet from Gibson's northwest corner, 97 feet to line of Mrs. B. H. Ellis, thence with her line in a northerly direction 56 feet, more or less to John Street, thence with John Street in a northwesterly direction 102 feet to the southeast corner of John and Hudson Streets, thence with Hudson Street in a southerly direction 80 feet, more or less to the beginning.
