All that certain piece of land situate and being in the County and State aforesaid near the town of Greenville, being part of tract I bought from R. P. Jones and having the following metes and bounds to wit: Beginning at an iron pine in center of road leading from Burkesville road to Hall's Mill Plant Corridor and running thence S. 57° 30' E. 610 to iron pine on Green Plant land, thence 90° to iron pine thence S. 40° 20' W. 317 to iron pine on R. P. Jones' line, thence N. 40° 20' E. 700 to iron pine in center of road, thence N. 31 E. 1.27 running with road to the beginning corner and containing one and one-half acres (1 1/2) more or less, courses and distances as per survey and plat made by W.
