all that piece, parcel or lot of land in Greenville

Township, Greenville County, State of South Carolina.

All that lot of land situate on the west side of McCall street in the City and County of Greenville, South Carolina, being a part of the lot conveyed to me by J. P. Jessinkiss, by Deed dated the 8th day of June 1918 and recorded in the office of R. M. C. in Book 426 page 485, the lot hereby conveyed described as follows: Beginning on said McCall Street Southeast corner of above described lot and running thence with McCall street in a northwestern direction 22 feet to corner of an easement of feet wide said easement being fully described in deed of the adjoining lot to E. L. McCrea's on the 16th day of May 1918 and recorded in Vol. 35 page 315 in R. M. C. office for Greenville County; thence at right angles with said McCall street along line of said easement to its south-west corner thence with the western line of said easement 7 feet to southern line of said E. L. McCrea's lot thence with line of E. L. McCrea's lot to southwesterly corner of said E. L. McCrea's lot to southwesterly corner of said E. L.
