all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina

near the City of Greenville, in the subdivision known as "Zematanah" and known as Lot #13 in Block "D" on revised plat of the said property recorded in the R.M.C. Office for said County. The said lot has the following notes and bounds: Beginning at a stake on the south side of Stewart Street, at corner of lot #12; thence along said Street N. 67-35 E. sixty feet to stake at corner of lot #14; thence along said lot S. 25-30 E. one hundred and sixty-five feet to stake at corner of lot #5; thence along said lot S. 67-35 W. sixty feet to stake at corner of lot #12; thence along said lot N. 26-20 W. one hundred and sixty-five feet to the beginning point on said Street. The grantee, by acceptance of this deed, covenants that she will not construct on said lot any surface closet nor toilet, but only septic tanks or such other sanitary sewers as may be provided by said grantee. This restriction is for the benefit of the other lots in this subdivision.
