In Ward Two, City of Greenville, on the north side of East Stone Avenue, having the following metes and bounds, according to a survey and plat thereof made by W. A. Adams Surveyor, to-wit: Beginning at an iron pin on the north side of East Stone Avenue (said pin being 110 feet distant from the corner of Main street and Stone Avenue), running thence N. 18. 12 E. more or less 132 feet to a stake thence S. 42 E. 52 feet and eight inches more or less to a stake in line now formerly of A. Katy; thence along said line S. 17. 34 E. 132 feet to a brick wall on Stone Avenue thence along said Stone Avenue N. 72. 0 W. 54 feet and four inches to the beginning corner.
